A plea bargain is when a defendant makes a deal with the prosecution or court to plead guilty in exchange for a more lenient punishment, or for related charges against them to be dropped.

### **PLEA OF NOT GUILTY AND WAIVER OF Case Number ARRAIGNMENT**
